CONTRACT FOR EXHIBIT SPACE

1. Exhibitor agrees to have his/her space in good order and to staff said space at all times while Show/Sale is open.
2. Exhibitor shall not assign this license, or sublet any part of the space hereby contracted for without prior permission of the Licensor.
3. Licensor reserves the right to change and/or alter booth space, is such change and/or alternation is not acceptable to the Exhibitor, Licensor agrees to refund all payments for said space to Exhibitor then resell the space.
4. Licensor reserves the right to prohibit the sale of any item(s) of Exhibitors, which in the Licensor's sole judgment is deemed to be not appropriate for any reason.
5. Licensor assumes and shall have no responsibility for any property of the Exhibitors used in connection with the Show/Sale. Furthermore it is understood and agreed that the Licensor is expressly released and discharged from any and all liabilities, loss, injury or damage to either persons or property that may be sustained on or about the premises of the Show/Sale or in connection with the Show/Sale.
6. Exhibitor shall maintain such insurance as will fully protect Licensor from any and all claims and shall pay claims for damages, including personal injury, which may arise from the operations of the Exhibitor. Furthermore, Exhibitor agrees to pay all cost for damages which he/she may cause to the Tent/Premise/Building containing the Show/Sale.
7. Exhibitor is required to hold all necessary licenses including tax licenses.
8. If, in the sole opinion of the Licensor, the Vintage, Antique & Collectables Show/Sale becomes unadvisable for any reason, the Licensor reserves the right to cancel the Vintage, Antique & Collectables Show/Sale at any time and return all rental monies to the Exhibitor that have been paid up to that time
9. The License may be terminated by the Licensor at any time on the breach of any of the conditions hereof by the Exhibitor, and thereupon all his/its rights hereunder shall cease and terminate, and any payments made by the Exhibitor shall be retained by the Licensor as liquidated damages for such breach.
10. Should the Licensor be subject to any dispute or legal proceeding for or on account of action on the contract, or negligence of the Exhibitor, Exhibitor shall pay the cost of defending such suit or proceedings including legal fees.
11. This agreement shall be binding upon the parties hereto and their respective executors, administrators, successors and assigns.
